Because our members are spread out over campus, meetings were held using Zoom for convenience. The two co-chairs also held monthly meetings to prepare for the full committee meetings.
Current Year Activities	<ul> <li>Recognize the challenges posed by mismatched schedules for parents and caregivers, especially regarding childcare and University involvement (UI).</li> <li>Continue efforts to improve communication and feedback channels between the shared governance council and charter committees.</li> <li>Diversify representation within the committee.</li> <li>Conduct a comprehensive review of campus lactation rooms with a focus on design and accessibility.</li> <li>Explore potential issues and solutions for shipping breast milk for traveling UI parents.</li> <li>Volunteer with the Childcare Taskforce to address childcare needs and solutions.</li> </ul>

# **Year to Date Actions Completed:** Supported a program for employee reimbursement for milk shipment for traveling UI parents. Expressed the need for more information needed regarding wellbeing during preboarding and onboarding phase and supported and promoted the creation of a consolidated Health and Wellbeing Resource Guide, available both online and in physical handouts, which can be used during preboarding and onboarding. Collaborated with various University bodies including the Faculty Senate, Committee on Committees, and Staff Council HR Committee to address family related issues. Created internship that resulted in the completion of a thorough review of campus lactation rooms, including an evaluation of cold storage, utilization, and functionality. Benchmarked practices and offerings of lactation spaces against other institutions. Partnered with the College of Education to establish a partnership in UI Wild, providing a backup care facility for days when the local school district is closed, and the University remains open for the upcoming academic year. Received central approval to add faculty as co-chair of this committee. Added male representation to the committee in efforts to diversify membership. Fold in the work of the Childcare Taskforce and review needs within this committee's scope. Continue to collaborate with shared governance groups on overlapping work. Continue collaborations with SC Commitee on Committees to diversify this committee. Continue conversation with Iowa City Community School District Administrators to explore options for Topics your committee anticipates addressing aligning school calendars (breaks/days off) with during the coming year university, where possible, and explore options for emergency or temporary childcare due to inclement weather cancellations, etc. Reach out to local Parks and Recreation departments to inquire about options or collaborations for providing emergency or temporary childcare due to inclement weather cancellations, etc. Other issues of concern Work on strategies to retain student member participation on this committee.

### **Recommendation 1**

Execute action plan from lactation room analysis, including updating webpage to include better information about accessibility and room layout/contents, creating a GIS map of the rooms, and provide better onboarding for those who are returning from leave on access, rights, etc.
